Any terms are subject to completion and approval of all required credit forms and signed dealer agreement.

Payment is due immediately and in full when product is retailed or removed from Dealership.

- Quik Pay Incentive Discounts are established by payment date. The Grasshopper Company will accept payments in advance of shipment and the
 applicable discount will be allowed.
- Late Payment: A carrying charge of one and one-half percent (1.5%) per month or the maximum legal rate, whichever is less, will be applied to all unsettled invoice amounts. <u>Inventory sold and not paid immediately is past due and the dealer will be liable for late payment charges until the amount is paid in full. All equipment and parts shipments will cease until payment for sold and unpaid inventory is received.</u>
- The Grasshopper Company, will withhold shipment to accounts whose account balance is not current. Accounts carrying any past due balance may not take advantage of applicable Quik Pay discounts. Any unearned discounts taken will be charged back.
- This program supersedes all previous programs, whether written, oral or implied. The Grasshopper Company reserves the right to modify or discontinue any program and incentive at any time. Prices may change without notice.
- Cash discount: Payments must be received, not postmarked, within 10 days of invoice date. Any cash payments received after 10 days time period will lose eligible discount. Cash discounts are only applicable on current accounts.

COST OF MISSING QUIK PAY INCENTIVE DISCOUNT

On shipments prior to Dec. 10, 2016: when Dealer submits payment within 10 Days of Invoice Date, Dealer is entitled to 4 + 1 Quik Pay Incentive.

If Dealer waits until the end of the discount credit period (July 10, 2017), the purchase will cost \$496 more on a \$10,000 invoice. In effect, Dealer has borrowed \$9,504 of \$10,000 purchase for 210 days or paid \$496 interest.

When annualized to 365 days, the 4.96% is as much as 9%.

By not taking the Discount, Dealer is missing opportunity to maximize the value of the purchase. This is known as a missed opportunity cost of not taking the available Quik Pay discount.

EXAMPLE FORMULA: Product Invoiced and Shipped Dec. 1, 2016 & Paid by Dec. 10, 2016 = $496 / 9504 \times 365 / 212 \times 100 = 9\%$ $496/(10,000-496) \times (365/July 10, 2017-Dec 10, 2016) \times 100 = 9\%$

PRICING Dealer's bid must be minimum 15% off MSRP for the entire bid equipment package sold, including unit/deck combination, accessories and implements. **DUE TO THE COMPETITIVE NATURE OF GRASSHOPPER PRICING, THE PRODUCT LINE IS VERY PROFITABLE FOR DEALERS. HOWEVER, A DEALER MAY NEED TO OFFER MORE THAN 15% OFF TO SECURE GOVERNMENT AND BID BUSINESS.**

GUIDELINES

- 1. Dealer must be current stocking dealer according to the Guidelines of the FIST Program.
- 2. Dealer must use MSRP for the Model year bid. A higher price than MSRP will cause the discount to be less than the 15% discount requirement.
- 3. National Cooperative Contracts, State Contract, BuyBoard, HGAC, GSA, TIPS, Fleet, National Accounts including CCW, SCI, FB, Grasshopper-subsidized Retail Financing, other Seasonal Sell-Through Programs and units with demonstrator discount cannot be combined with this program.
- **4.** If bid unit is not in Dealer inventory, note "BID ASSIST" on sales order form submitted to factory at **grasshoppermower.com/wgorders** for clarification of 4% Bid discount allowed.
- 5. Grasshopper reserves the right to request further documentation on any information pertaining to the bid claim.
- **6.** If End-User requires payment or lease options, contact the Grasshopper Bid Department for non-factory subsidized finance options and lease information.

CLAIM AND CREDIT PROCEDURE

To receive Bid Assist rebate and freight credit on sale, submit the following:

- 1. Payment in full to Grasshopper for entire bid package delivered. Do not deduct bid rebate or freight when paying invoice.
- 2. The 4% Bid discount is locked-in for Bid Assist. This discount is the only deduction that may be taken when payment for Bid package is made. The discount does not apply to freight. If unit is in paid Dealer inventory and less than 4% Bid discount was originally taken, Grasshopper will honor up to 4% Bid discount on Dealer's account. Grasshopper will also credit the Dealer's account normal freight based on Dealer's freight bulletin, excluding LTL or Factory Rep delivery charges, when Dealer has not charged a freight or setup fee to the End-User. Turbine blowers and Shielded Sprayers will incur normal freight which is not credited.
- 3. Completed Warranty Card.
- 4. Copy of Invoice to bid customer.
- 5. Completed Claim Form.

GRASSHOPPER BID SERVICES

GOVERNMENT PURCHASING TOOLS

Grasshopper has State, National Cooperative and Federal contracts available to aid in the purchase of Grasshopper turf equipment. Most contracts carry the full Grasshopper line, implements and accessories. The benefit to the government customer is being able to purchase Grasshopper product from contracts secured through a competitive bidding process. Bid assist credits issued to the Dealer are based on the Grasshopper Bid Assist Program less any fees associated with the contract. The Grasshopper Company processes the reporting of all fees and usage reports associated with the contracts. Grasshopper dealers will be able to create quotes based on available contracts for your state on the *Grasshopper Quik Quote*, accessible from *Dealer Depot*.

STATE CONTRACTS

Grasshopper has secured State Contract agreements with numerous States across the U.S. Please check with your Factory Representative about State Contract purchasing programs for your State. Most All State Contracts have language allowing political sub-divisions such as schools, cities, counties etc...to "piggy-back" off these contracts. This saves agencies time and money from the tedious bidding process. Use the Bid Assist Claim form to submit sales activity to Grasshopper Company and note on the Claim form the State Contract used for the purchase on the claim form. State Contract units count towards VBPP. No other programs or subsidized finance programs can be used in conjunction with state contract program. The Grasshopper Co. can deny any claim that does not match state contract pricing or guidelines. Leasing is available with State Contract pricing.

If you have a State Contract for your State, be sure you have the latest price list available. The Grasshopper Company provides state contract flyers and most all contracts will be in *Quik Quote*.

NATIONAL COOPERATIVE CONTRACTS

The Grasshopper Company currently has contracts with **Buy Board, HGAC and TIPS** cooperatives. Each of these cooperatives have set pricing and carry Grasshopper's full line of equipment. Pricing changes based on the contracts dates associated with each competitive bid, so be sure to check the current pricing when quoting. The Grasshopper Co. will process all reporting and usage fees associated with the contract. Use the Bid Assist Claim form to submit sales activity to Grasshopper Company and note on the Claim form the Contract used for the purchase on the claim form.

Cooperative Contracts are ideal to use when there is no State Procurement Contract in a given state. National Cooperative Contracts work well for local government agencies such as schools, cities and 501c entities (non-profit). National Cooperative units count towards VBPP. No other programs or subsidized finance programs can be used in conjunction with National Cooperative program. Leasing is available with National Cooperative pricing. The Grasshopper Co. can deny any claim that does not match National Cooperative pricing or guidelines.

GSA

Grasshopper Mowers are available on GSA contract. If working with a Federal location such as a Military Bases (Forts, Camps, Air Force Bases), USDA, Naval Installation, Department of Interior etc...contact the Grasshopper Bid Department for pricing quotations, specifications or assistance in working with federal buyers for the purchase of Grasshopper equipment.

FLEET ASSIST PROGRAM

EFFECTIVE Sept. 1, 2016 through August 31, 2017

ELIGIBLE END-USERS Fleet Operator - a full-time contractor or grounds maintenance professional who owns multiple commercial riding mowers (two 36" or larger walk-behinds equal one commercial riding mower). This Program is intended for Fleet Operators who:

Intend to upgrade or expand their existing fleet

Are not eligible for normal bid terms

Are not part of a Preferred Customer Account

PRICING Selling one or more units (power unit + deck) to the same qualified Fleet Operator at minimum 15% off MSRP allows the Dealer to submit a Fleet Assist claim. These sales must be invoiced/delivered simultaneously to the same End-User to qualify for the following:

4% Fleet discount locked-in for Fleet Assist on the entire purchase, including Accessories and Implements purchased at the same time as the unit(s). The 4% discount is calculated on Dealer's net cost, excluding freight. If equipment was previously paid with less than 4% Fleet discount, additional discount up to 4% total will be entered on Dealer's account.

3% Fleet rebate **OR** Grasshopper Subsidized* Financing

Freight credit for normal shipping costs as outlined on the Freight Bulletin, excluding LTL and Factory Rep Delivery cost when freight and setup charges are passed on to the End-User. Freight is not credited to Dealer for Turbine Blowers and Shielded Sprayers.

* Grasshopper Company contributes to buy-down of interest rate. Standard dealer participation fees apply to retail financing

GUIDELINES

- 1. Fleet Rebate or normal freight credits will be posted to Dealer's account once payment is received and the claim procedure has been approved. <u>Do not deduct those credits at time of payment submittal.</u>
- 2. Spiff Program and Volume Bonus Program will be applicable to the sale. No other programs may be combined with Fleet Program. May not combine multiple user purchases on single order.
- 3. V Series Models qualify for the 1.5% Fleet discount held for Fleet Assist and Grasshopper may credit normal freight when the machine is retailed at a minimum 10% off MSRP and the claim procedure described in this program is followed. V Series models do not qualify for the 4% Fleet discount locked-in for Fleet Assist OR 3% rebate, but may be financed with approved credit.

FIRST-TIME GRASSHOPPER USERS To qualify turf care professionals when purchasing Grasshopper for the first time, please submit grounds management verification. For example:

Photo of End-User's fleet equipment, truck and trailer

Link to End-User's website or copy of other advertisement

End-User's business card including business name, contact name and address

Itemized list of End-User's fleet (required on claim form), including year, current fleet make/model

CLAIM AND CREDIT PROCEDURE

- 1. Copy of Dealer's retail sales invoice to Fleet customer.
- 2. Completed Fleet Assist Claim Form & Grounds Management verification.
- 3. Warranty Registration Card for each power unit, deck & implement sold.
- 4. Payment for retailed equipment.
- 5. All claims must be submitted within thirty (30) days of the sale.

The Grasshopper Company will withhold shipment to accounts whose account balance is not current. Accounts carrying any past due balance may not take advantage of applicable Fleet discounts.
